#### Note:

- 1. Academic Fee will be charged semester-wise.
- 2. Relaxation to SC/ST candidates in the fee is as per Uttar Pradesh government norms/rules.
- 3. Registration fee is a one-time non-refundable fee, and not a part of academic fee. It will be compulsory for all Courses/Programmes. This fee is non-refundable.
- 4. Security Fee (Caution Money) of Rupees Ten Thousand only will be charged for all Courses/Programmes. This is refundable after submission of no dues certificate from all Departments through the Dean of the school. Security Fee (Caution Money) is not applicable to Foreign/International Students.
- 5. The university is a residential university, wherein its Act prescribes for residing in the hostel. So the students shall have to stay in the hostel by paying the hostel & mess fees.
- 6. Hostel exemption would not ordinarily be allowed. Only in exceptional circumstances can it be allowed on a case to case basis by the competent authority. However exemption will be granted for married students or having any chronic ailment requiring regular therapy with ongoing hospitalization, continuously or intermittently. Such candidates may submit their application in the office of student affairs (forwarded by concerned Dean of school) within 15 days from the date of admission closing. No hostel and/or mess exemption application will be considered after due date. The exemption application applications are proceeded session wise. During the internship the student exemption is given for mess charges, when a student is ongoing for an internship outside of the campus.
- 7. Shortlisted Ph.D. candidates who are not getting fellowship from any organization may also be considered for teaching load in the concerned school/s on merit basis.

8. Fee would be liable to change from time to time, as determined by the Fee Review Committee.

#### 9.2 FEE STRUCTURE FOR FOREIGN NATIONALS

The fee structure shall be decided or may be revised by the competent authority of the University from time to time. Academic fee and Hostel fees are same for the foreign Nationals from SAARC and ASEAN Nations and India Nationals. In addition to the above academic fees as mentioned above in Point 8.1-Table B.

## A separate Registration fee will be charged from Inter- National student's which is as under:

- 1. **Foreign Nationals of SAARC and ASEAN Countries: One time registration fee of US\$500** (or equivalent in Indian Currency as per the prevailing exchange rate) for Non-Technical and/or Non-Professional Programmes of all the Schools, as the case maybe. Whereas, US \$1000 (or equivalent in Indian Currency as per the prevailing exchange rate) for Technical and/or Professional Programmes of all the Schools, as the case maybe.
- International Students of other than SAARC and ASEAN Countries: One time registration fee of US \$700
  (or equivalent in Indian Currency as per the prevailing exchange rate) for Non-Technical and/or Non-Professional Programmes of all the Schools, as the case maybe. Whereas, US \$1500 (or equivalent in Indian Currency as per the prevailing exchange rate) for Technical and/or Professional Programmes of all the Schools, as the case maybe.
- One time registration fee of US \$200 for Diploma/Certificate programmes from Foreign Nationals of SAARC and ASEAN Countries and US \$400 for Diploma/Certificate programmes from foreign nationals of other than SAARC and ASEAN Countries.

#### 9.3. POLICY FOR REFUND OF FEE

#### **Voluntary withdrawal from the Programme:**

- 1. Academic fee shall be refunded in case of withdrawal of admission from the programme of study in which He/she is enrolled as per UGC norms.
- 2. Security deposit shall be refunded in full.
- 3. Once the hostel is allotted then hostel fee for the semester shall not be refunded in case of withdrawal of admission.
- 4. Mess fee shall be refunded to all the students on prorata basis.
- 5. The last date of seeking admissions, as communicated in the provisional admission letter shall be treated as the final date of admission.

## 10. RESERVATION/RELAXATION POLICY

- 1. The reservation and relaxation policy as per Uttar Pradesh Government and Gautam Buddha University rules.
- 2. The sports person providing evidence of participation in National/International level events maybe provided 5% relaxation in respective qualifying examination.

#### 11. GENERAL INSTRUCTIONS

Gautam Buddha University - Entrance Test (GBU-ET 2024) will be inside GBU campus in offline/online.

#### The Number of seats in all the Ph.D program maybe increased or decreased.

Qualifying exam only from Government recognized National/International bodies/National level board (s) State level board (s) shall be considered for admission in various programmes of the University.

Candidate may apply for more than one programme at a time, however application fee for each separate programme will be charged.

A self-attested copy of valid score (s), as applicable, will be required at the time of interview/counseling for admission. The admission in the programme shall be provisional until the candidate furnishes all the required documents, fee and testimonials etc. including final result of the qualifying examination. The University reserves the right to cancel

the admission of student(s) at any point of time if there is any discrepancy found in the eligibility of his/her candidature as per eligibility criteria laid down in the Ph.D Admission Brochure 2024-24 (Even semester).

#### 12. FOR CANDIDATES OF PH.D.

Abbreviations: FT- Full Time, WP- Working Professional.

- 1. Ph.D. applicants must be required to submit are relevant Research Proposal in approx. 1500 words at the time of interview. In the title page of the Ph.D. proposal, the discipline and the mode of admission (Full Time/Working professional) should be specified. They may also submit the list of publications or other search credentials, if any.
- 2. The candidate appearing in qualifying examination may also apply, however, Ph.D. students will be required to produce the proof of having acquired the minimum prescribed qualifications at the time of interview purpose of admission in to Ph.D. programme.
- 3. University recognises Chartered Accountant (CA) & Company Secretary (CS) qualifications (along with graduation degree) as equivalent to post graduation for the purpose of admission in to Ph.D. Programme in relevant area in University School of Management as per UGC guidelines.
- 4. The Entrance Test for Ph.D. Programmes shall be qualifying with qualifying marks as 50% for candidates belonging to General and OBC category (45% for SC/ST) as per UGC Guidelines.
- 5. The Entrance Test shall be qualifying with qualifying marks as 50%. The syllabus of the Entrance Test shall consist of 50% of Research Methodology and 50% shall be subject specific. For the detailed syllabus of the Ph.D. entrance test exam of Subject Awareness and Research Methodology, candidates are advised to visit admission link available on the university website (<a href="https://www.gbu.ac.in">www.gbu.ac.in</a>).

#### SPECIFIC INFORMATION ONLY FOR JRF EXEMPTED CANDIDATES FOR GBU-ET-2024

- 1. Online registration is MANDATORY for all interested candidates who are seeking admission in Doctoral Research programme leading to Ph.D. Degree (Ph.D. programme) through online admission portal of the Gautam Buddha University (GBU).
- 2. Candidates who have qualified Junior Research Fellowship (JRF) through UGC/CSIR/DBT/ICAR-ASRB Examination ONLY, and NET along with Qualified for Ph.D. category or qualified for Ph.D. only are exempted from appearing in the GBU Entrance Test (GBU-ET) for admission into Ph.D. programme of the GBU. However, they are required to fulfill other minimum eligibility criteria as per UGC / GBU rules and regulations.
- 3. Only JRF / NET along with qualified for Ph.D. category or qualified for Ph.D. only candidates are advised to OPT for either "GBU-ET" OR "Exemption from GBU-ET" mode of the Examination.
- 4. Interview panel will award marks to the candidate(s) based on the presentation by the candidate about his/her Academic Background, Area of Interest and Research Proposal as mandated by the UGC Ph.D. Degrees Regulations, 2016.
- 5. For JRF/ NET along with qualified for Ph.D. category or qualified for Ph.D. only / GBU Entrance Test Qualified Candidate: selection of candidate will be based on weightage of 70% of UGC Test Score / GBU-ET Score and 30% to the performance (based on interview marks format). If JRF candidate from other accredited body appear without score, then interview will based on 100 marks format. (All Ph.D. interview format attached)
- 6. As the marks in UGC JRF / NET along with qualified for Ph.D. category or qualified for Ph.D. only are given out of 300, so GBU-ET marks will also be awarded out of 300 for making equivalence.
- 7. Additionally, 05 Marks will be extra to the JRF qualified candidates and 3 Marks will be extra to the NET along with qualified for Ph.D. category or qualified for Ph.D. only if they appear through GBU ET.
- 8. Preference for selection will be given to the candidate(s) i.e. merit list will be prepared on the basis as under: i. ii. iii. First preference will be given to the JRF qualified candidate(s). Second preference will be given to the GBU-ET qualified candidate(s). Third preference will be given to the NET along with qualified for Ph.D. or qualified for Ph.D. candidate(s).

9. The reservation rules will be applicable uniformly on the seats advertised for each of the Department / School of the GBU.

The candidate (s) is/are required to possess two years of teaching and/or research experience from National Institutes of higher learning/Universities/Central Laboratories or two years' experience from Industry/R&D of an industry at an appropriate level.

The candidate (s) is/are also required to produce **NOC** and a **letter of consent** from his/her organization, **for providing sufficient facilities and time for completing the course work and conducting the research,** at the time of interview for admission.

The candidate (s) is/are required to complete their course work in class-room mode during first year.

#### 14. ONLINE APPLICATION PROCEDURE

Online submission: Online application form and Ph.D admission Information is available on the University website: <a href="https://www.gbu.ac.in">www.gbu.ac.in</a>. Application fee is to be paid through Credit Card/Debit Card/ Net Banking/UPI.

- 1. Candidates are advised to read the Ph.D Admission Information carefully, check their eligibility and applicable reservation category etc. before filling and submitting the application form. The application forms shall be available in the online mode only from the University Website: http://www.gbu.ac.in. Applicants are advised to go through the demo video to fill the form.
- 2. The applicants are advised that they must keep the details of their login-id and the password secure and safe as the form filling as well as admit cards shall be made available through the online mode only.
- 3. The incomplete/wrongly filled online application forms shall be rejected.
- 4. It is the responsibility of the candidates to ascertain whether he/she possesses the requisite eligibility and qualifications for admission. Applying for a particular entrance test, appearing for the written examination and qualifying the same does not necessarily mean acceptance of eligibility.
- 5. All applicants will get all information through the University website (www.gbu.ac.in). A candidate would be responsible for not visiting GBU website for required details.
- 6. Issuance of admit card doesn't ensure the eligibility of the candidate for admission in any programme.

- 10. The University accepts the prescribed fee only. A candidate is required to contact his/her own banker for the refund of the fee payment which is debited in excess during the online transaction. The University would not entertain the queries related to refund of application fee which is not credited in University's accounts.
